Statement

Plenty Canada is committed to safeguarding the privacy and personal information entrusted to us by our donors, supporters, volunteers, employees, and board members. Personal information will only be used for the purpose for which it was collected.

The statement outlines the policies and practices to be followed to protect your personal information based on the requirements in the Personal Information Protection and Electronics Documents Act (PIPEDA). Personal Information

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages, and other statistics.
